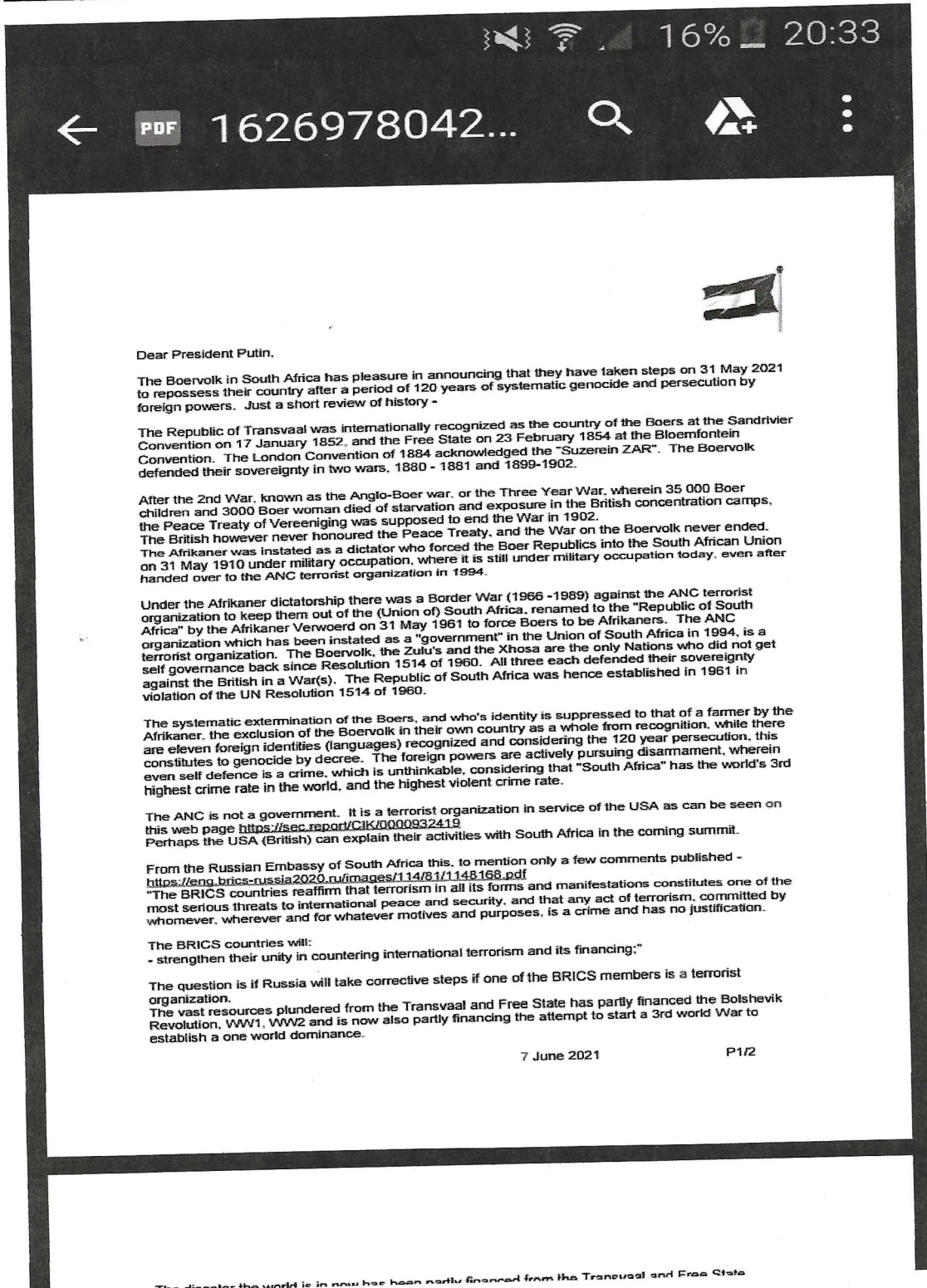

Dear President Putin,

The Boervolk in South Africa has pleasure in announcing that they have taken steps on 31 May 2021 to repossess their country after a period of 120 years of systematic genocide and persecution by foreign powers. Just a short review of history -

The Republic of Transvaal was internationally recognized as the country of the Boers at the Sandrivier Convention on 17 January 1852, and the Free State on 23 February 1854 at the Bloemfontein Convention. The London Convention of 1884 acknowledged the "Suzerein ZAR". The Boervolk defended their sovereignty in two wars, 1880 - 1881 and 1899-1902.

After the 2nd War, known as the Anglo-Boer war, or the Three Year War, wherein 35 000 Boer children and 3000 Boer woman died of starvation and exposure in the British concentration camps, the Peace Treaty of Vereeniging was supposed to end the War in 1902. The British however never honoured the Peace Treaty, and the War on the Boervolk never ended. The Afrikaner was instated as a dictator who forced the Boer Republics into the South African Union on 31 May 1910 under military occupation, where it is still under military occupation today, even after handed over to the ANC terrorist organization in 1994.

Under the Afrikaner dictatorship there was a Border War (1966 -1989) against the ANC terrorist organization to keep them out of the (Union of) South Africa, renamed to the "Republic of South Africa" by the Afrikaner Verwoerd on 31 May 1961 to force Boers to be Afrikaners. The ANC organization which has been instated as a "government" in the Union of South Africa in 1994, is a terrorist organization. The Boervolk, the Zulu's and the Xhosa are the only Nations who did not get self governance back since Resolution 1514 of 1960. All three each defended their sovereignty against the British in a War(s). The Republic of South Africa was hence established in 1961 in violation of the UN Resolution 1514 of 1960.

The systematic extermination of the Boers, and who's identity is suppressed to that of a farmer by the Afrikaner, the exclusion of the Boervolk in their own country as a whole from recognition, while there are eleven foreign identities (languages) recognized and considering the 120 year persecution, this constitutes to genocide by decree. The foreign powers are actively pursuing disarmament, wherein even self defence is a crime, which is unthinkable, considering that "South Africa" has the world's 3rd highest crime rate in the world, and the highest violent crime rate.

Establishment of ZABR Tribunal

Pledge

Under the ZABR Jural Assembly of the Common Law Court of Justice and the Jurisdiction of Natural Law and the Law of the Nations

We hereby declare ZABR Tribunal to be represented by the following sovereign Boervolk members:

Chief Justice :	Jan Diederiks -	Appointments of 'Justices of the People' to serve the Boervolk
Sheriff :	Marius Roos -	Appointments of 'Peace keepers' and 'Protectors' of the Boervolk
Commissioner	David vd Berg -	Appointments of 'Commissioners' within the Volkshuis departments to serve the Boervolk

All commissions / appointments are to be agreed and signed by all members of the Tribunal and witnessed by 2 independent sovereign Boervolk members.

These appointments are applicable for a 3 year period with the option to extend for a further 3 years should it be deemed necessary by the Tribunal.

Resignations from the Tribunal require a 3 month notice period. Any Tribunal member may be replaced by majority vote of the Tribunal if deemed necessary.

Replacement of the 3rd party in the Tribunal shall be at the discretion of the Tribunal only.

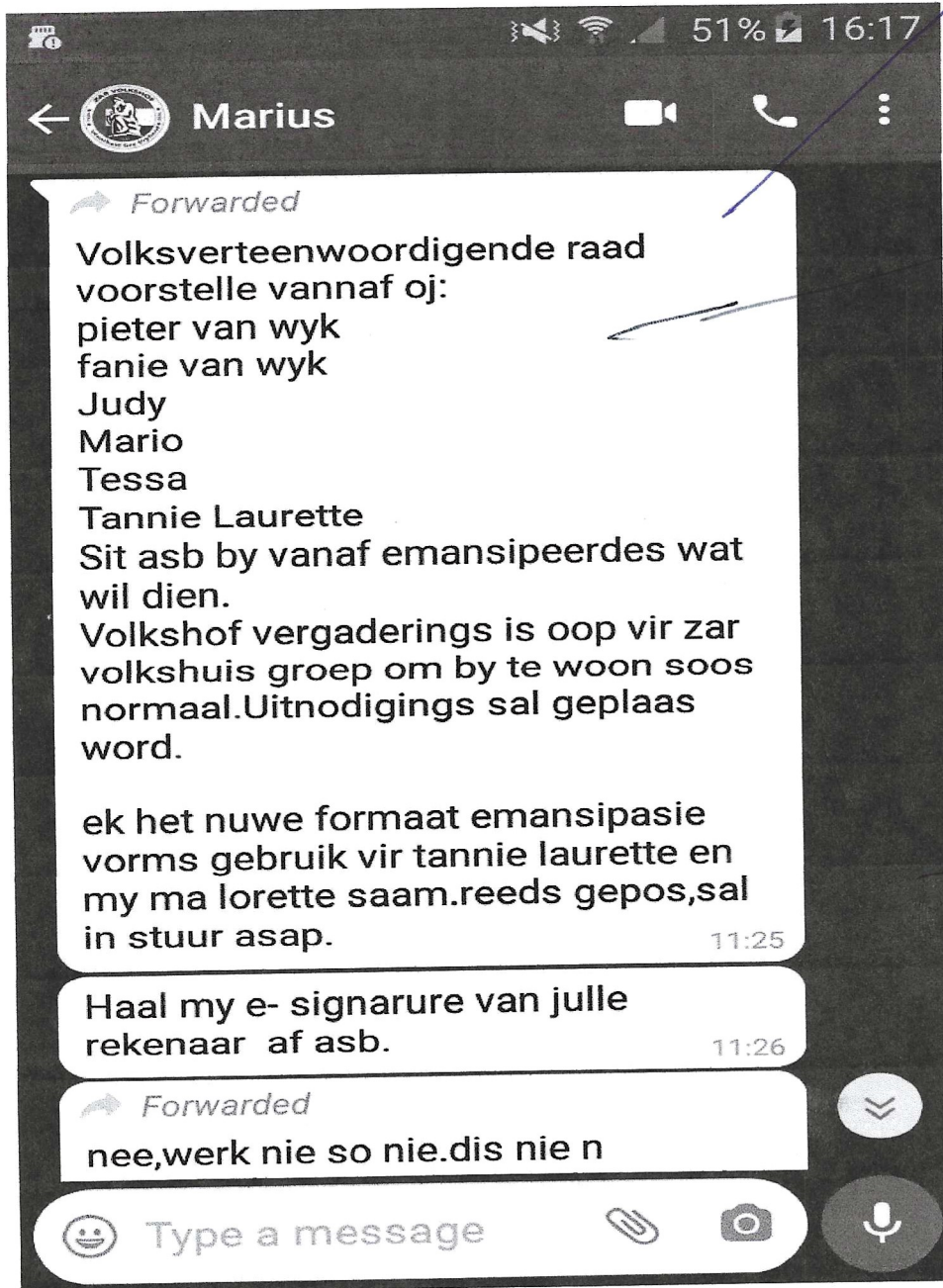
