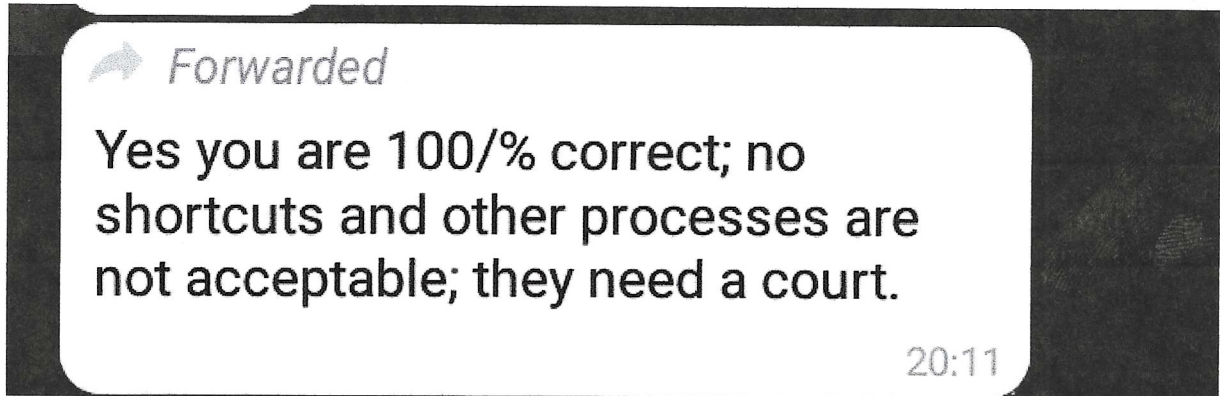

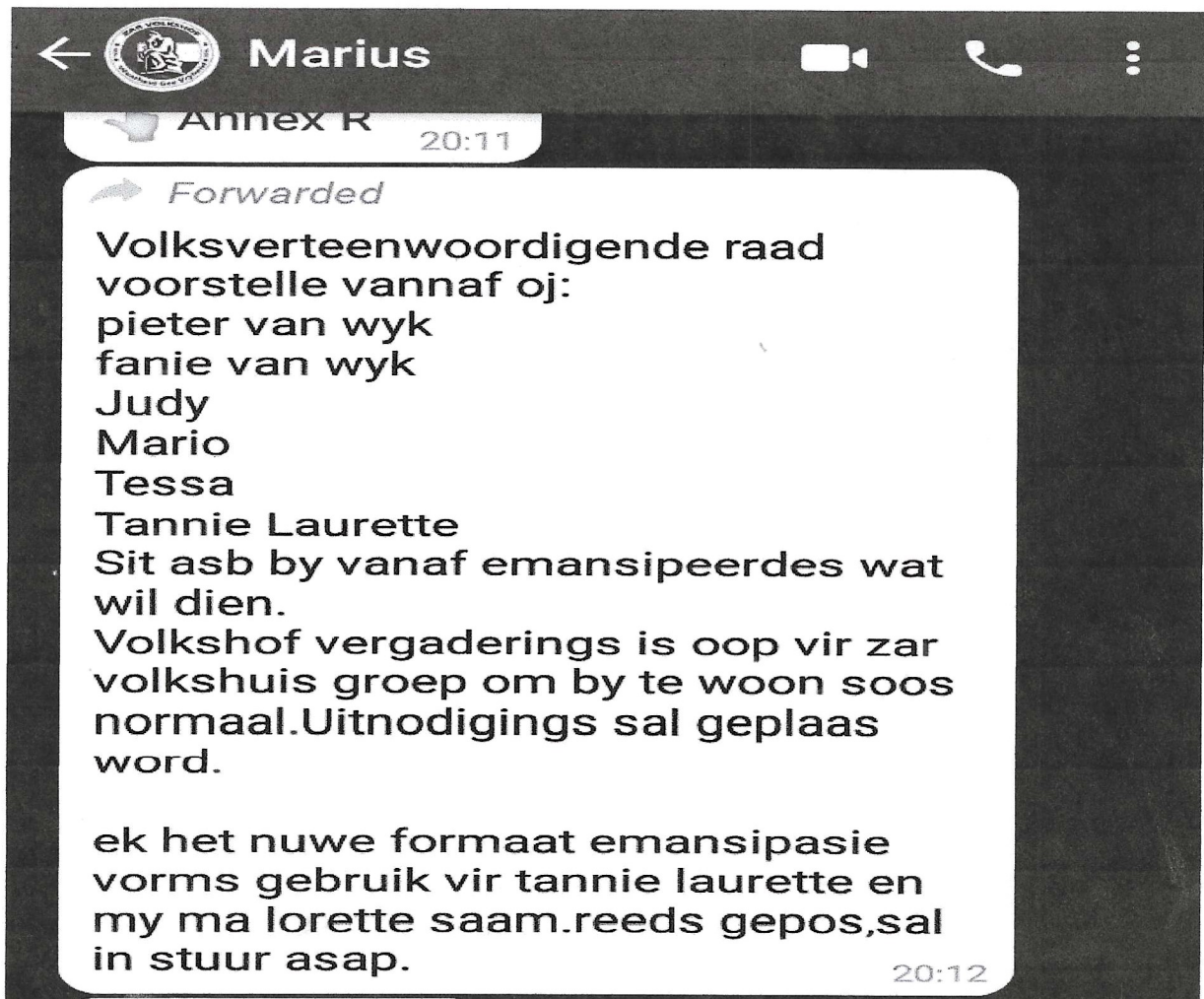

# BRIEF DECLARATION OF EMANCIPATION BY BOERVOLK

29 May 2021

The following are ten essential precepts for the establishment and realisation of the Boervolk (Boer Nation) by means of the emancipation of the Boervolk in the legal framework of the Zuid-Afrikaanse Republiek; as it was and still is recognised in international law:

## 1 Heritage

Members of the Boer nation declare themselves to be creations of the Great Creator of Heaven and earth and are therefore only accountable to Him.

Therefore they must remain genetically, spiritually and morally pure and faithful to His Laws of Creation.

They need as naturally endowed property their history, science, knowledge, culture, language, land and all property, as well as the right to defence to be non-negotiable assets which should not be given to or shared with other groups, nations or tribes to the detriment of the Boer nation.

They recognise that the commercial world of the British Empire exercised power over many nations' national assets through wars, murder and they desire to rectify those injustices.

## 2 Recovery of freedom from and subservience to the remnants of the Empire

The Boer nation demands total freedom from the bonds of the foreign and local Corporations, authorities, governments and entities claiming ownership or mastery over any member of the nation or of the Boervolk as the nation as a whole.

This demand is for total unconditional freedom as an irrevocable right endowed on this nation by its Creator. Any other nation in their own right to have the internationally recognised freedom in their own historical environment.

The Boervolk and its members will be absolved of the corporate debt of the corporation of the Corporate Republic of South Africa and this includes the loans against their so-called Birth Certificates and identity in the Corporations.

### Claim of Right

All members of the Boer nation will submit their Claim of Right to be independent from the Corporations, the lien of the state against their beings, the claim of the British Crown, the Vatican, and all and any entity that claim or intend to claim any authority or historical superiority against or over the Boer nation. Some members' presented claims are already accepted by all entities addressed and no other claims can be opposed based on the precedents already established.

This claim of Right endows the Boer nation and its members with the right to establish a full government structure with unencumbered international authority over its own affairs, including the rights of protection and defence of the property it recognises and inhabits.

## 3 Authority

The Boervolk and its members claim authority over any and all entities and corporations whether established by individuals, other entities or the state, which in itself is a fiction created by man.

This authority extends to include entities and corporate structures established by the members of the Boervolk themselves.

The authority and rights of members of the Boervolk to own land, property, medicines, firearms and ammunition, trading structures, community associations, ideology, science, art, and cultural pursuits will not be encumbered.

#### **4 The Right to Trade Unencumbered and without Usury**

The Boer nation and its members claim the right to trade without any constraint, racial discrimination, personal limitations based on race, ethnicity, regulatory biases from Corporate South Africa or any fictitious entity provided it is by mutual consent of both parties and that none of the parties are in corruption or bankruptcy or trade with bankrupt or corrupt entities.

The Boer nation prohibits the employment of usury in any form and anyone found to be trading or contracting with an element of usury in such dealings, will be excluded from membership of the nation and of the right to continue trading in the nation.

All trading must be by mutual consent.

#### **5 Right to Education and Embracing National Culture**

The Boer nation will enforce the right to education of their children and training of their members in the ways of their culture and by parental guidance free of proscription by the government of the Boer nation. Groups of members of the nation are allowed to agree amongst themselves to the means and content of education and training of consenting members.

Incorrect historical or corrupting teachings will be presented to the national tribunal for evaluation and may result in chastisement.

#### **6 Right to individual inviolability of the person of members**

Any violation of the person or body of a member of the Boer nation will be considered a punishable crime. This includes any medical procedure or intervention that may be considered desirable by any authority to which the member or related family has not consented. All actions to combat any malady or disease will require full disclosure of the suggested action, the risk involved, the cost and the patient has to give full consent to the actions presented.

#### **7 Establishment and function of a national court of law**

The Boervolk will establish a National Court system based on the principles of Juries to hear and judge cases of dispute or crime. This court will be convened by members to also execute the following functions:

- Constitute a Legal system and a national constitution along the principles of the original ZAR before the corruptions by commercial interests, recognising the UN Resolution 1514 Column XV of December 14, 1960, and conforming to basic freedom and justice;
- Communicate with other states or nationalities;
- Ensure the sanctity of the constitution and defend it against corruption;
- Institute legal action and claims for damages, material or in kind, to the Boer nation and their ancestors, their Republic, their mineral rights, their murdered population and war damages against the Roman Church, the British Empire, participating corporations and organisations and persons and their families including related trusts.
- Institute legal actions against the Banking entities, individuals and organisations that were complicit in the denuding of the assets of the nation including the transfer of gold and material assets to the Federal reserve bank and other entities without *due quid pro quo*.

#### **8 Claim to territory**

The Boer nation claims full title and rights to the whole area that constituted the internationally recognised territory occupied by the ZAR as established in January 1852 and the Republic of the



Orange Free State in February 1854. This is the territory before the annexation of Kimberley to rob the nation of the diamonds; the Jameson Raid to destabilise the ZAR to claim the gold mines and the war of attrition waged by Britain, supported by her colonial territories, from 1899 to 1902, incorrectly named the Anglo Boer War.

## **9 Means to an End**

In order to achieve the freedom and independence from the corruptly established Corporation called the Republic of South Africa so that they can live free from oppression and in national sovereignty and justice according to their culture and to incorporate the just objectives stated in this document, the members of the revived Zuid Afrikaanse Republiek claim their individual rights of freedom - thus individually emancipating from subservience to the corrupt and murderous British ruled Corporation of the Republic of South Africa. This claim of right is without prejudice or intended prejudice to any other historical nation or group and without violence or insurrection.



## Introduction

The “that without which not” of any matter is to find the truth. And, the truth is that:

- 1] We have no lawful government;
- 2] We have no lawful courts;
- 3] We have no permanent banking system;
- 4] We have no lawful money;
- 5] Banks create money out of thin air;
- 6] We have no freedoms or rights; and, if we did they are not enforceable;
- 7] We do not own our car or house or land or property; we do not even own our legal names or our children.
- 8] We have no credit, only debt; our savings in the bank belongs to the bank who is renting it out;

- 1] **Southern Africa Jural Assembly** to assist communities with common law or customary law courts;
- 2] **Zuid-Afrikaanse Boer Republiek (ZAR)**, a free and independent republican state.

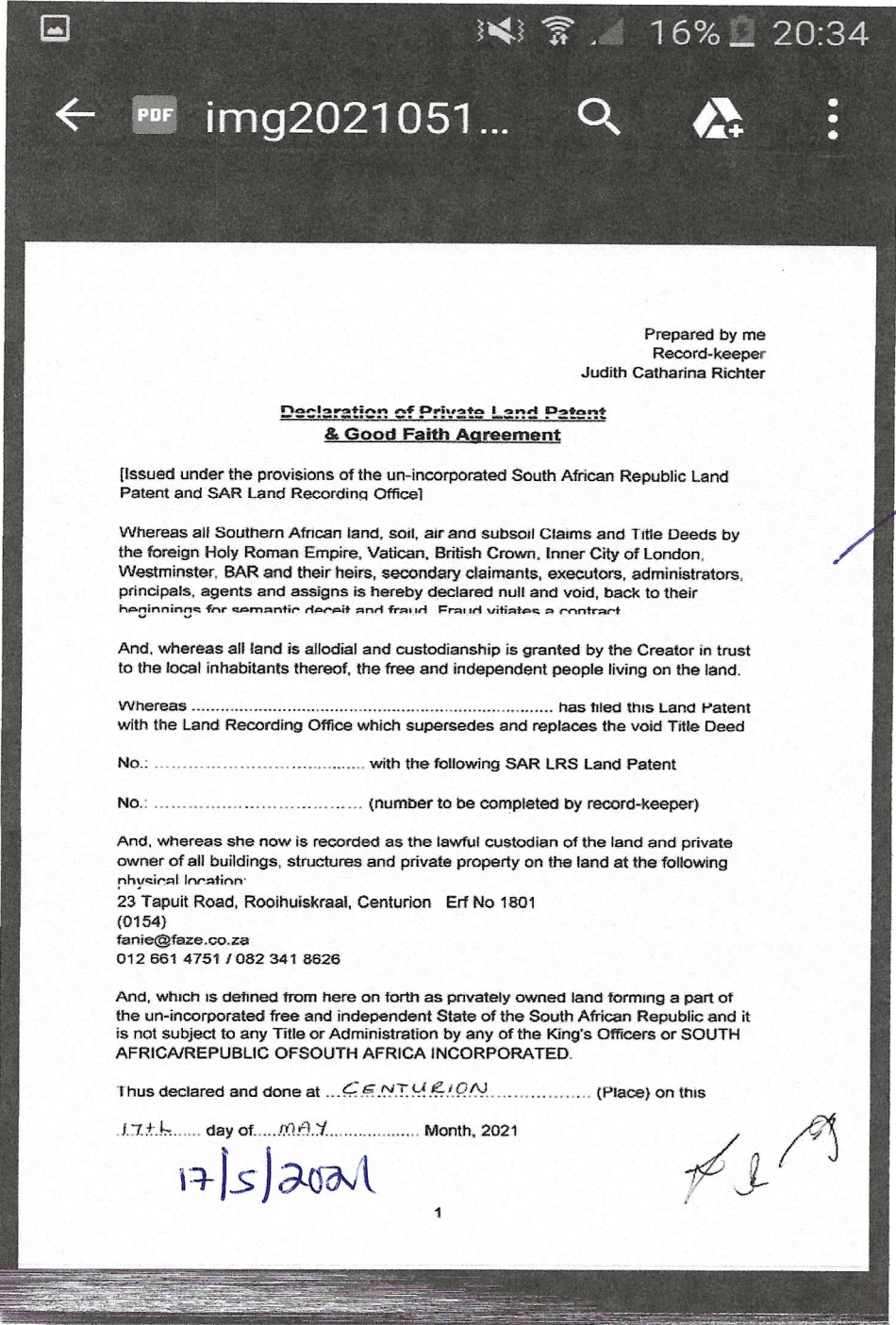
